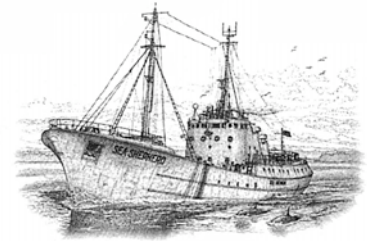

The vessel *Ady Gil* was intentionally/negligently rammed by the *Shonan Maru No. 2*, a vessel owned and operated by your company.

The *Ady Gil* sunk as a direct result of that collision, and your company is liable for the full replacement cost of the *Ady Gil*, which is at least US \$3,000,000.00.

Please contact Sea Shepherd Conservation Society's office in Friday Harbor to arrange payment details.

If we have not received payment by April 1, 2010, we will be proceeding with a civil action in Japan against your company. We will be seeking punitive damages, in addition to the full replacement cost of the *Ady Gil*.
